Children's Library Reorganization

Staff continues to update and organize the children's book collection, including merging and shifting youth fiction to make it easier for community members to locate books. Storage and workroom areas have been cleaned and organized during the building's closure. Other

Library Manager and Cultural Arts Coordinator Recruitments

Library Manager interviews are scheduled for March 11, 2021. Over sixty applications have been received for the new Cultural Arts Coordinator position. Interviews are currently scheduled for March 15, 2021.

Library Park Activation Project

Engineering, hardscape, and landscape design continue for the Learning Garden and Storybook Loop. Plans should be available for input from stakeholders and the Development Services Department soon (March/April 2021).

FY 2021-2022 Budget

Preliminary budget discussions are underway due to the upcoming shift in the City's Fiscal Year (from October-September to July-June). A Budget Study Session with the City Council is currently scheduled for April 20, 2021 from 2-4 PM.
